
An up-to-the minute website now promotes Childminding on a global and local level and gives members the opportunity to advertise their business directly to the families in their area.

This year has been a very special one for NICMA. **25 years** of supporting and developing the Childminding sector has seen many changes, both in the early years and childcare policy arena, as well as in the actual delivery of high quality childminding for children and families. As well as continuing with our strategic objectives during the year, we have also tried to raise the profile and celebrate everything that's good about Childminding and show how Childminding really has touched the lives of many thousands of children and families over the years.

We have continued to invest in our **Media & Public Affairs strategy** and believe that the much higher profile of Childminding in the public and political arena over the last few years has paid dividends. We have lobbied for a number of years about the absolute need for Childminders to hold public liability insurance cover and were pleased this year that the Northern Trust made it a mandatory requirement of registration, bringing them into line with the rest of Northern Ireland.

Rural families have traditionally faced difficulties in accessing suitable childcare and we were delighted therefore that the **Rural Childcare Programme** through DARD recognised the value of developing Childminding as a solution to rural families childcare needs. The funding awarded for a pilot/demonstration project for a time limited period of 16 months will allow NICMA to target those rural communities most in need of new Childminding provision. The project will also enable us to deliver and evaluate a Childminding Recruitment & Training model that can be replicated in other communities beyond the life of the project.

NICMA's **Childminding Network scheme** continues as a model of good practice within 11 of the Sure Start

programmes. With the first Networks now established for nearly 3 years it seemed appropriate to carry out the first evaluation of the Childminding Network model to examine how they are helping Sure Start to achieve its objectives through the delivery of home-based childcare. In the year ahead we will be launching the report and taking on board any recommendations arising from the evaluation.

As I write this report we await the introduction of a **new**Childcare Strategy and hope that it will address those fundamental issues facing the sector which impact not only on the quality and quantity of provision, but also on parents' ability to return to employment. We still face serious shortages in Childminding provision, there are many barriers to registration and there continues to be a lack of investment and policy direction with regard to enhancing quality through training. These issues must be addressed if we are to improve outcomes for children and offer equality of access for women entering the labour market.

To continue to thrive as a strong, stable voluntary organisation requires commitment and hard work from a range of individuals working as part of a wider team - the newly established **Board of Trustees**, the **Childminding Advisory Council** ensuring that the members' voice and issues are represented and a **dedicated**, **enthusiastic staff team**. Everybody involved must be commended for their continued efforts to ensure that Childminding is the best option for children!

Childminding Development

The right for families to have access to affordable quality childcare is fundamental to Northern Ireland's future economic prosperity, to tackling child poverty, and to achieving the best possible outcomes for all children. Childminding is the most affordable and the most popular full time daycare option for working families in Northern Ireland. It accounts for nearly 60% of fulltime daycare places and 37% of all childcare places here but there still remains a serious shortage of registered Childminders. Many Childminders in Northern Ireland also face lengthy delays when they apply to become registered.



In an attempt to improve the situation NICMA's **Childminding Development team** were set a number of key objectives linked to the recruitment and retention of Childminders over the period of this report. Table 1 indicates the key objectives and associated outcomes.

Barriers to Childminding Registration

NICMA have identified that many prospective Childminders are facing a number of barriers linked to the completion of the Childminding registration process. This is having a serious effect on Childminding recruitment. In December 2009, NICMA carried out a survey of newly registered Childminders which found:

- Respondents faced an **average wait of seven months** to obtain their registration certificate
- just one in five prospective Childminders had their registration processed within the three-month period stipulated in legislation;
- one in five waited ten months or longer; and
- · Just over half (54%) felt the wait time was too long.

The effect of these lengthy registration delays is twofold: it is likely that many prospective Childminders simply give up and quit the profession. Secondly, long delays in the process are providing an incentive for Childminders to remain unregistered, putting the children they look after at potential risk.

There is little doubt that these delays are contributing to the large number of **unregistered Childminders** in Northern Ireland. This same survey indicated that just over **one third (35%)** of respondents said they knew of at least one unregistered childminder operating in their area and **17**% said competition from unregistered Childminders was having an impact on their business. A higher proportion of respondents in the Western and Southern Trust areas reported this problem. The impact of viability of Childminding businesses is a real cause for concern especially for those newly registered Childminders setting out to establish themselves. This will be a key focus of NICMA's work in 2010/11.

One respondent, who waited nine months and considered giving up, commented:

"After the [pre-registration] course,
I was really motivated and had
everything ready to start working,
but then I had to wait for months.
I had to find other sources of income,
and lost my focus on becoming
a childminder."

NICMA's Childminding Advisory Council

In 2007 NICMA carried out an internal review which in turn led to changes in the overall governance of the organisation. The previous NICMA Executive Committee was replaced by a new Board of Trustees in an attempt to bring a more diverse range of knowledge and skills to NICMA and to support the long term sustainability of both the organisation and the Childminding sector. NICMA recognised the importance of retaining the Childminding voice within the new Board structure and 25% of board members are Childminders.

In order to ensure that a wide range of 'grass roots' issues for Childminders were fed back through to NICMA's Board of Trustees, senior management and staff team NICMA set up a Childminding Advisory Council. The Advisory Council met for the first time in May 2008 and continues to meet 4 times a year, on Saturday mornings rotating locations to accommodate members from across Northern Ireland. Key pieces of work car<u>ried out to date have included:</u>

- Setting suggested annual Childminding charges
- · Developing a committee procedures manual
- Reviewing the NICMA membership pack
- · Participating in NICMA 25th anniversary events
- Promoting Childminding recruitment and NICMA membership services
- Reviewing the NICMA group constitution
- Fundraising and negotiating Childminding discounts
- Supporting NICMA week activities
- Supporting the development and dissemination of the Group newsletter and the Parent's newsletter.

In 2009 NICMA linked up with **Bookstart** and **Libraries NI** to invite Childminders and their minded children to a number of special Rhymetime sessions run by library staff. NICMA Week events are organised on an annual basis to raise awareness of how registered Childminders promote children's learning and development in a home-based environment. Bookstart Rhymetime sessions are activities designed to encourage parents and carers to share rhymes and songs with babies and young children. Sessions incorporate a mix of songs, rhymes, rhythm and movement and provide an opportunity for adults to interact with children and promote language and movement in an enjoyable way.



Promoting Accessible Rural Childminding

With funding from DARD through the Rural Childcare Programme, NICMA's newest project will promote and encourage registered childminding in those rural areas most in need of additional childminding provision. Individuals will be encouraged to consider childminding as a profession and provided with a range of support and training to help them set up their small childcare business. The project will also ensure that rural agencies involved in or affected by childcare will have a voice and a part to play within the project.







Training and Quality Initiatives

NICMA recognise the wide knowledge and complex skills required by home-based Childminders in providing a quality family day care service to children and families. We believe that high quality, accessible, affordable and relevant training should be available to all registered Childminders.

NICMA's Training department continued to deliver a range of training and quality initiatives throughout the year; this is despite NICMA receiving **NO** core funding towards enhancing the quality of Childminding provision through training. All of NICMA's funding for training has to be applied for year on year and as a result of successful funding applications to various sources, the value of the training delivered by Training department staff was **£68,463** as per the audited accounts.

This year **60** courses were delivered to a total of **775** learners. Although this shows a drop in the number of courses delivered there has been a marked increase in the number of longer courses delivered i.e. courses delivered over 8 modules. Two of the Introduction to Home-based Childcare courses were delivered to Approved Home Childcarers and 2 were delivered in Polish in the SHSCT Area.

The table below shows a sample of some of the courses which were delivered this year in comparison to the year previous.

Many of those childminders who have completed training with us this year really enjoyed the experience and were able to put their learning into practice.



In addition to the training delivered by the training department staff the childminding development and network staff delivered the following:

"Developmental Programme for Two Year olds" Training Course

NICMA tutors delivered this course for the first time to registered Childminders who lived in the Southern Health and Social Care Trust area. The course was fully funded by the Southern Area Childcare Partnership (SCP) Early Years Development fund.

"I have thoroughly enjoyed this course, interaction with the rest of the childminders was great, learning from their experiences and taking new ideas on board too" 13 Childminders accepted places and completed the course. They agreed that all of the children in their care benefited from them attending the training. The training consists of 8 Modules which include:

- Introducing the Two Year Old Child
- · Value of Play / How Young Children Learn
- Influences and Innovations / Creativity
- Learning together in partnership with parents communities & other professionals

Although the training was aimed at children aged between 2 years & 2 months – 3 years & 2 months, due to the nature of the childminding environment, children up to the age of 12 years were also able to benefit. In total:

- 21 children aged 2 years & 2 months 3 years & 2 months benefited from the knowledge gained
- 32 children under 5 years and 19 children over 5 years benefited from the knowledge and skills gained by the childminders

A detailed evaluation was carried out with childminders, parents and children during and after the course was delivered which produced very positive findings.

"I am now more aware that a 2 year old is constantly looking for information i.e. extending their knowledge, stimulation, excitement, involvement and exploration."



Supporting families through Sure Start Childminding Networks

There are 11 **Childminding Networks** attached to Sure Start programmes in Northern Ireland which are jointly managed by NICMA and by each of the respective Sure Start programmes. A Childminding Network is defined as:

...a formal group of registered Childminders who are recruited in a particular geographical area and assessed and monitored to quality standards by a Childminding Network Co-ordinator. The Network is a means of ensuring that Childminders provide a high quality care and education service to children and families. A Network can consist of between 10-30 Childminders, depending on local requirements, providing up to 90+ Childminding places.

The networks in Northern Ireland are modelled fairly closely on those approved by the National Childminding Association in England and Wales. They are all underpinned by a commitment to enhancing the quality of care of their members.

Childminding Networks are attached to Sure Start programmes in the following areas:

Clogher Valley
ABBEY (Newtownabbey)
G-old (Cookstown area)
Shantallow (Derry)
Little Hands (Derry)
Strabane
Horizon (Carrickfergus & Larne)
Splash (Lurgan & Brownlow)
Coleraine
Blossom (Portadown)
Arke (Keady, Armagh, Callanbridge)

Childminding Networks have significant benefits for parents, children and Childminders including:

- Provision of childcare places, enabling parents to return to work or training, or to continue in their employment/training
- Reassurance for parents that their children are being well looked after
- The provision of back-up care through the network if a child's usual childminder is sick



Key benefits of the networks for children:

- The enhancement of the quality of care provided by Childminders who are network members, in particular, through access to training
- The variety and quality of activities provided for children by network members
- The opportunity for children to mix with other children at the network drop-ins
- The opportunity to go on outings organised by the network which parents either could not easily afford or could not easily manage to organise themselves
- Improvements in all areas of children's development including social skills



At 7.3%, Strabane has one of the highest levels of unemployment in Northern Ireland. In December 2007, the Strabane Sure Start centre teamed up with NICMA to appoint Clare McGillion as a part-time Childminding Network Co-ordinator. Clare quickly discovered that just

20 registered Childminders were active in the town and that there was a clear shortfall in provision.

So she set about persuading suitable individuals to take up a career in Childminding. Within just over 2 years, she had recruited 10 new registered Childminders. In effect, she had increased the number of registered Childminding places in the town by 50% - a huge boost for parents hoping to access job opportunities who want to use quality childcare.

"Touching Young Lives"

A toolkit to Support Early Learning in a Home-Based Setting

In October, as part of NICMA's 25th Anniversary Conference, the Minister for Education, Caitríona Ruane launched **"TOUCHING YOUNG LIVES"** a toolkit for Childminders.

NICMA devised this developmentally appropriate toolkit for Childminders to use in their own home. It provides a common framework and practical tools that will help all Childminders realise the learning potential of activities and experiences offered in a home-based setting. This will assist Childminders in the planning and implementation of natural and planned learning opportunities within the home which will improve the experiences of the young children for whom they care.


A training course 'Promoting Early Learning & Well-being in Home-Based Settings' was also developed to support the implementation of the toolkit into the everyday routine for Childminders.

NICMA is a membership organisation and professional body working to support and develop quality homebased childcare for the benefit of children, families and communities.

We provide a full range of support services for Childminders and home-based childcarers which all help to enhance the quality of the childcare.



offered as part of the annual Membership package. Average 'hits' to the site have increased to around 300,000 per month, showing a growing interest in the services we have to offer.

NICMA Membership

NICMA Childminding membership has dropped in - year with a decrease of 5% - this is mainly due to natural wastage within the sector but also can be attributed to the economic difficulties Childminders find themselves in. To try and counteract this downfall, this year we introduced a number of incentives to encourage Childminders to continue with their membership including loyalty discounts and a price freeze on membership fees for the 3rd year running. As a result, we recruited **466 brand new members** throughout the year.

Childminding Information & Advice

Good quality information and advice on all aspects of Childminding is an essential service for both members, and parents and for those interested in Childminding as a profession. During the year, we received over **25,000** enquiries covering topics ranging from contractual issues, Childminding fees, registration delays etc

Our **newly designed Web Site** has improved the service offered to both members and to the general public. Members are now able to manage their own Childminding vacancies on-line and at the year end, **800** members opted to market their service this way. Parents looking for a Childminder now have much improved information and access to an on-line vacancy facility. The development of a specific **'Members Forum'**, providing a wealth of information for Childminders, is yet another benefit

Extended Childminding

More Childminders are recognising the need to be flexible in their service to meet the needs of parents and this year, we have over 50 Childminding businesses providing an extended service where they work with an assistant or partner to extend the places available.

Sonia Bennet and Tracey Doran from Craigavon set up 'Mighty Mums', their Childminding Business in October 2007, are NICMA members and have signed up to Splash Sure Start's Childminding Network. They are registered to care for 8 children and also provide childcare places for the Splash Sure Start Emergency Childminding Scheme.

Sonia and Tracey operate the Childminding business on an equal partnership basis which they find has many benefits. Sonia explains:

"Tracey and I have a great working relationship; it reduces social isolation and is really helpful to work with another adult to share knowledge and experience." Mighty Mums operate their business from Sonia's home and not only do the children benefit from being cared for in the home environment, they also have a dedicated play area where the children have more freedom to participate in physical and creative play. Mighty Mums are also very supportive to new Childminders in the area and are very keen to offer advice and often refer parents to local Childminders starting their business.

Lisburn Childminder Wins Cow & Gate

Childminder Of The Year



Lisburn childminder Irene Leonard was selected as the 2009 winner of the Childminder of the Year Award. Stefan Menet of sponsoring company Cow & Gate, said, "We are delighted to be working with NICMA on the Award this year, especially in their 25th anniversary year. Childminders are a very important part of many households all across Northern Ireland and provide a service which is second to none. Cow & Gate recognises the sterling work they do and through these awards are able to recognise and reward the best of them. NICMA's financial position for the year ending 31 March 2010 is reported in the statement of financial activities as indicated above.

The ongoing financial support awarded by the Department of Education and the 5 Health and Social Care Trusts has enabled NICMA to continue with core services and childminding development throughout Northern Ireland. Although the future stability of this funding is uncertain, NICMA continues to provide and promote essential services to its members and to children and families.

Although NICMA's expenditure increased by 5% in 2010 compared to the previous year, the income decreased slightly by 1%. Thus we are reporting an overspend of £77,676 at the end of March 2010.

Low bank interest rates coupled with reduced funds held resulted in our investment income falling during 2010. However, action has now been taken to review these investment funds and new deposit accounts have been opened to maximise their return. On a more positive note, NICMA maintained relationships with all of their Sure Start programmes. This partnership continues to contribute significantly to NICMA, accounting for almost a quarter of the total annual income and expenditure.


In December 2009 we were successful in our bid to DARD for inclusion in the Rural Childcare Programme and have embarked upon a project which has impacted on our 2010 accounts and will continue through all of 2011. NICMA has committed to contribute a small financial percentage (5.9%) to this project but will hopefully reap future benefits from recruiting new childminders in the designated rural areas.

NICMA's 25th anniversary year was celebrated in style which in turn was accompanied with a notable financial impact. Earlier in this report you will have read about the 'Finger Painting Challenge' and the 'Hillsborough Castle reception' amongst other events. Funding for these events was extremely limited and thus we had to bear the majority of costs ourselves although the publicity received was immense and the overall celebratory atmosphere was enjoyed by all.

On behalf of the members of the Board of Trustees, I would like to conclude with my thanks to all stakeholders, members, staff, volunteers, and funders for all their support of childminding, without whom NICMA would not be able to offer what we believe to be the best childcare option for our children.


